b) "1 First by Nord Est"(logo) Style No. I602HB hooded coverall with integral boots, with elasticated hood, wrists & waist and a front zip closure covered by a storm flap.

c) "1 First by Nord Est"(logo) Style No. 1602C collared coverall, with elasticated ankles, wrists & waist and a front zip closure covered by a storm flap.

All garment styles are manufactured using a white micro-porous film laminated to a non-woven fabric with sewn seams and available in five nominal sizes, plus custom sizes to order.

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the relevant requirements of the harmonized standards:

EN ISO 13982-1:2004 + A1:2010 (Protective clothing for use against airborne solid particulates) for Type 5, limited wear life full body protection;

EN 13034:2005 + A1:2009 (Chemical protective clothing offering limited protective performance against liquid chemicals) for Type 6, limited wear life, full body protection;

EN 14126:2003 (Protective clothing against infective agents) for Type 5-B, 6-B, limited life, full body protection.

In addition with one exception the PPE satisfied the requirements of EN 1073-2:2002 (Protective clothing against particulate radioactive contamination - Non-ventilated clothing) with a performance classification of TIL Class 1. The exception is that clause 4.2 specifies that the minimum puncture resistance should be level 2, but the fabric used has a puncture resistance classification of level 1.

Additionally the fabric met the requirements given in EN 1149-1:1995 for electrostatic dissipative protective clothing on the internal surface.
